OBJECTIVE

Health Systems Transformation Platform (HSTP) is leading the charge in providing technical support to the state government to effectively implement the Biju Swasthya Kalyan Yojana (BSKY), the flagship government-funded health insurance scheme in Odisha. HSTP is closely collaborating with the State Health Assurance Society (SHAS), the scheme's implementing agency, to enhance personnel capacities, improve operational and clinical processes, ensure better engagement with stakeholders, and contribute to better financial risk protection and improved health outcomes for the beneficiaries.

The main objective of this workshop was to improve the efficiency, effectiveness, and transparency of claim adjudication and medical audit processes within the BSKY scheme. Additionally, the workshop introduced the International Classification of Diseases (ICD-11) for standardised diagnosis documentation, which is expected to improve the transparency of these processes. The workshop was designed to provide re-orientation training to the doctors responsible for overseeing BSKY operations and to enhance their skills in claim adjudication and medical audit processes.

In partnership with the State Health Assurance Society (SHAS), the workshop was conducted to provide learning and development opportunities to 145 SHAS doctors who play an integral role in the BSKY operations. The workshop aimed to equip doctors with the necessary knowledge and skills to improve the quality of the healthcare delivery system within the BSKY scheme.

- 1. **Introduction to BSKY:** Overview of the scheme, its objectives, and the impact on healthcare delivery in Odisha.
- 2. Health Benefit Packages: Detailed explanation of the various health benefit packages under BSKY, including eligibility criteria and benefits.
- 3. **Principles of Claim Adjudication:** Critical examination of the criteria and processes involved in evaluating and processing claims within BSKY.
- 4. IT Workflow of Claim Adjudication: Insight into the IT framework supporting claim adjudication processes.







- **5. Principles of Medical Audit:** Explored medical audit techniques, focusing on desk and field audits, to ensure accountability and quality in healthcare delivery.
- **6. Fraud Prevention Strategies:** Strategies to detect and prevent fraud, ensuring the transparency and integrity of BSKY operations.
- 7. Introduction to ICD-11 Coding: Training on the latest ICD coding system to standardise diagnosis documentation and improve healthcare data analytics.

SUMMARY OF DISCUSSIONS AND KEY TAKEAWAYS:

The workshop focused on the necessity for stringent guidelines for the use and administration of high-end drugs and antibiotics at empanelled hospitals. Participants agreed on the need for culture sensitivity reports and adherence to Antimicrobial Resistance (AMR) policies before prescribing such antibiotics. This is crucial to curtail the rampant misuse of antibiotics, which can lead to the development of antimicrobial resistance. Furthermore, the discussion led to a consensus on the imperative to cap the costs of high-end antibiotics, chemotherapy drugs, and implants to foster more equitable access to healthcare. The lack of uniformity in the expenses claimed by hospitals for these treatments, especially without supportive GST invoices, was identified as a critical area for improvement. To increase transparency and accountability in healthcare billing, it was suggested that all high-value claims should be submitted along with authentic GST invoices.

Additionally, the workshop highlighted several areas for improvement in hospital claim processes and policy adherence. It was noted that adjudication of hospitalisations for Acute Kidney Injury (AKI) treatment and haemodialysis often face challenges when claimed simultaneously, underscoring the need for policy adjustments to better cater to patient needs. The irrational use of multiple antibiotics without proper justification by hospitals was also a point of contention, with a call for CPDs to scrutinise such practices rigorously. Establishing an AMR policy in empanelled hospitals was proposed to support accurate diagnoses, justify treatments, and facilitate optimal care. Furthermore, the workshop advocated for the preauthorisation of additional necessary treatments, such as hemodialysis in ICU settings and conservative management claims, with proper justification from hospitals. Strengthening medical audits, rationalising the use of medical packages, and ensuring that claim processes are supported by adequate documentation were identified as crucial steps towards achieving a more efficient, transparent, and equitable healthcare system.







KEY OUTCOMES

- 1. Augmented comprehension of BSKY's operational framework and the critical role of medical audits and claim adjudication in ensuring scheme efficiency.
- 2. Advanced expertise in identifying, preventing, and managing fraud within the BSKY framework.
- 3. Knowledge of ICD-11 coding, enabling more accurate and standardised diagnosis reporting.

PARTICIPANT FEEDBACK

The workshop received an overwhelmingly positive response from the participants, as evidenced by the feedback collected. 95% of the attendees rated the workshop as either 4 or 5 on a scale of 1 to 5, indicating excellent satisfaction and perceived value. The participants' testimonials highlighted the workshop's practical benefits and effectiveness. For instance, insights such as gaining a "Better idea about claim management system" and "Got clarity in claim adjudication" were mentioned as key takeaways, demonstrating the workshop's ability to deepen knowledge and refine skills in these critical areas.
